President's Remarks

The "voice" for Illinois forests!? I would have to say we are making some inroads, but we have a long, long way to go to reach that goal.

Your Board is nearing its first full year of existence, and we are sometimes wondering if we are making a difference--for you and for the state's forest resources. From my viewpoint, knowing what your Board is involved in and has done in our short existence, I feel our voice is being heard. Let me say, I see your Board coming together more and more. We are discovering our roles and taking more individual initiative in our positions as officers, as directors, as chairpersons, or as members of committees. We are growing together as we need to in order to make a difference. We all have different roles and individual strengths that will continue to support our "voice" throughout the regions and throughout the state.

We have exerted a presence in Springfield in the last four to six weeks, laying groundwork for increased IDNR Forestry Division staffing, full restoration of the 4% timber harvest tax monies, and addressing the timberland assessment issue. We hired a young lobbyist out of Chicago to help us make our "voice" heard. He had the knowledge, the contacts, and the abilities to give us direction, set up meetings, and get us into discussions with key legislators, the Governor's staff, and others so our issues were heard. Later in this newsletter, you will read more details on these and future lobbying activities.

We are evolving and growing as we strengthen our "voice". We cannot do either without you, our members. In a recent letter, I invited you to send your concerns and thoughts to be shared in a "Members Voices" column that will start with this issue. Better yet, or in addition, call or email one or both of your directors. We need your "voice" to become a stronger association. We also need more of you to help us more actively. Tell us what you might be willing to do. I promise you we want and need more active members! Call me, call your directors---we need your help, your voice!!

Technical Action Committee Report

I attended the National Forest Products Utilization and Marketing Conference in Madison, WI, June 4-7, 2007. Over 82 forest product specialists from over 30 states participated, including specialists from industry, USDA Forest Service, state forestry agencies, universities, and Cooperative Extension Service.

Conference highlights: Tour of Madison state capital restoration project; tour of USDA Forest Products Laboratory; Forest Product Laboratory initiatives and research program reorganization; USDA State & Private Forestry reorganization; details about the USDA Wood Education and Resource Center (WERC – http://www.na.fs.fed.us/werc/) and Hardwood Value Improvement Project (HVIP); National Forest Products Utilization and Marketing Directory (http://www.fpl.fs.fed.us/tmu/); Northeastern Area Association of State Foresters; Madison Area Technical College Cabinetmaking and Millwork program; biorefinery & bioenergy; and technology transfer. The Forest Products Laboratory research and technology transfer mission and current focus areas include under utilized woody biomass, nanotechnology, biorefinery/bioenergy, advanced wood structures, and advanced composites. The two biggest topics at this year's conference were the USDA Forest Service restructuring issues (federal dollars, programs, and headcount) and biorefinery (i.e., woody biomass and bioenergy utilization).

I'm also proud to announce that the Lincoln Heritage RC&D office based in Tuscola, IL (Douglas Co.), has recently acquired contractual services from two consulting foresters. Primary services offered include forest management plan development, forest inventory and analysis, and intermediate stand management. The following counties are serviced by Lincoln Heritage RC&D: Champaign, Coles, Cumberland, Douglas, Edgar, and Vermilion Counties. Voices for Illinois Forests

On March 30, IFA Vice President J. B. Gates and Region 4 Director Joe L. Newcomb met with State Representative Brandon Phelps (D), Illinois 118th Representative District, in his Harrisburg office. We wanted to get acquainted with him and to help him get acquainted with the IFA and its members and to emphasize the importance of forestry in Illinois. We learned that Rep. Phelps is vice chairman of the House Agriculture and Conservation Committee and that Rep. Dan Reitz (D), 116th Representative District from Sparta, is chairman of this Committee. He assured us that both share our interest in Illinois natural resource issues.

We gave him copies of the new IFA brochure and membership application forms and asked him to join. He said he would seriously consider it and that he would ask Chairman Reitz to also consider joining. Rep. Phelps offered to host a meeting with IFA leadership and Chairman Reitz. We also left for his office files copies of IFA Bylaws, IFDC description, Interview with White County Supervisor of Assessments Nancy Winter, and a letter about forestry issues.

While talking about the woodland tax assessment issue, Rep. Phelps advised that Rep. Kurt M. Granberg (D), 107th Representative District from Centralia, is the champion of this issue and would love to speak to our group about his findings, the current status of the issue, and where we are likely to go from here. We told him we were planning our annual meeting at Rend Lake Resort. He said it would be even more likely that Rep. Granberg could be persuaded to speak at our annual meeting at this site because of his historical ties to Rend Lake. Also, if Rep. Granberg's schedule doesn't permit an appearance, Rep. Phelps would be glad to fill in for him.

We discussed the 4% "sweep" issue. He said each representative in the House was asked to "check-off" which funds would <u>not</u> be affected by future "sweeps". He checked the 4% fund. Evidently, he has heard our complaints about the sweep of the 4% fund and voted against any more sweeps on it. He added that, largely due to the Illinois budget crisis, once the 4% money is spent, it is unlikely to be restored.

Regarding restoration of IDNR staff positions, Rep. Phelps was aware of the concern citizens have expressed and offered that it is apparently caught up in the overall Illinois state budget work with which the Legislature is struggling. Also, the Administration has more authority and responsibility in the personnel area than does the Legislature.



From Region 2

The Region 2 Spring Meeting took place at the farm of Gail, Yvonne, Terry and Tammy Smith in eastern Adams County. This operation consists of 736 acres, including 200 acres of managed forest land. The two primary goals of the Smith's management plan are to harvest each tract once every 10 years and to maintain a healthy forest to benefit wildlife. Terry and Tammy have a small sawmill operation, which they use to serve a niche market which mainly consists of hobby wood workers and wood turners. A small part of the farm is also planted in wildlife cover for deer and turkeys.

Some 26 members and guests attended the meeting. A short business meeting kicked off the event with a discussion of current state legislation affecting forestry. Members were urged to make their presence known at the local office of their state representative and senator and to voice their opinion concerning several bills which would affect their forestry operation. Also, District Directors urged those in attendance to set up an IFA recruiting table at local events, such at county fairs. Banners, applications, and brochures are available from the state IFA headquarters to aid in this effort.

Jeff Waterman of Outdoor Power in Quincy gave a presentation on small engines used in forestry operations. Jeff also teaches a course on small engine maintenance at John Wood Community College in Quincy. The use of fresh, pure gasoline and the correct heat in replacement spark plugs was emphasized. Stabilizer should always be added to gasoline as soon as it is purchased to avoid a breakdown when the ambient temperature goes over 85 degrees. Also, a too-hot replacement plug can severely damage an engine.

After lunch, IDNR District Forester Bob Church and consulting forester Jeff Hudgens led the group on a walking tour of a part of the forest where TSI work was done about two years ago. Several excellent stands of oak were observed. Also, walnut trees were in bloom, having missed the Holy Week freeze that wiped out the acorn and hickory nut crop for this year. This may well be the only mast for wildlife this year.

IFA is active in Region 2. We urge all IFA members to become active in their regions and to pass along their concerns, ideas, and observations to their District Directors. The Directors can then report these at the quarterly board meetings and initiate any action needed at the state level. IFA is a grass roots organization. We want and need member input.

From Region 3

Nearly 100 people from throughout the state participated in the Timber Management Planning Practicum at Stephen A. Forbes State Park in Marion County on June 5, 2007. Lots of discussion centered on woodland tax assessments and forest management plans as a way to continue to receive the preferential assessment.

The agenda featured IDNR foresters, private forestry consultants, and forestry students and faculty from SIU Carbondale. Landowners and students received on-the-ground training in the components of a forest management plan--assessment of the landowner's objectives for the forest resource; site inventory; timber stand improvement (TSI); and invasive species, wildlife, and erosion control considerations. The goals of the practicum were to:

(For the Landowners)--Instill an appreciation for and understanding of the work of forestry professionals and the importance of forest planning; educate them about the conservation and financial benefits of planned forest management, the current tax assessment process,

- and the elements of forest land planning; provide time for discussion with other landowners and with forestry professionals.
- (For the Forestry Students)

 Provide an opportunity for them to learn first-hand from seasoned mentors; allow them to practice the elements of forestry planning; encourage them to move forward in their chosen discipline; help prepare them to become certified forest planners.
- (For the Professional Foresters)--Make effective and efficient use of their time by sharing their expertise with a large group of landowners and students.

The Lincoln Heritage, Post Oak Flats, and Wabash Valley Resource Conservation and Development Councils and the Illinois Forestry Association hosted the event. A second practicum, targeted to U of I students and local landowners, is planned for this fall. The practicums are funded by a Forest Land Enhancement Program grant to the RC&D Councils.

Forest Facts

from Private Forests Are at Risk; The Need for Action in the 2007 Farm Bill

- Development pressures An average of 1 million acres of private forests is converted every year to development.
- Forest health problems 27 million acres of nonfederal forests are at risk of insect and disease damage, including invasive pests, and an estimated 90 million acres are at risk of wildfire.
- Minimal planning for the future Management planning helps families make a long-term commitment to the land. Yet estimates suggest that only 3% of family forest owners have a written management plan.
- Minimal professional advice Professional advice helps landowners avoid unintended, poor management, yet only 22% of family forest owners have received professional advice prior to harvesting timber.

Lobbyist Report

Jeff Riley, former IFA lobbyist

It was a pleasure to represent the Illinois Forestry Association for the past five weeks. During this time, I was always well received by members of the Illinois General Assembly, the Governor's Office, and other staff in the Capitol. I found this interesting despite the fact that the Association did not have a lobbyist presence in years past. Whether it was regarding the lack of staffing in the IDNR Forestry Division or the issue of the Timber Tax, people responded positively when they learned that the Association was concerned.

In the short time I was employed by the Association, President Ray Herman and I were successful in meeting with a number of influential legislators and staff about the above said issues. This work helped raise awareness of the Association at the Capitol and in the process, helped us identify a number of members who can serve as champions for the Association's causes and concerns in the future. Examples of these include Senator John Sullivan, who said he was willing to push the staffing issue during budget



negotiations; Senator Mike Frerichs from Champaign; and Senator Jeff Schoenberg, who is an excellent northern Cook County Senator and a good example of a more "urban" champion. On the House side, Representatives Brandon Phelps, John Reitz, and Sara Feigenholtz seemed very willing to help the Association.

In addition to relationship building, we also tracked and weighed in on a number of pieces of important legislation including:

- Senate Bill 281, which provided that revenue from the sale of timber under the State Forest Act shall be deposited
 into the Forestry Development Fund instead of the Wildlife and Fish Fund;
- Senate Bill 1617, which created the Emerald Ash Borer Revolving Loan Program and the Emerald Ash Borer Revolving Loan Fund; and
- Senate Bill 17, which deals with the important land valuation issue.

Looking ahead for the Association, I am pleased to hear that another paid lobbyist has been retained. I believe it is imperative for the Association to continue to have a strong presence in Springfield. In addition, as I outlined in my initial action plan, I also think it is important for Association members to visit and communicate with their own representatives and senators this summer. This dual communication, with someone in Springfield and with people in the districts, will ensure that members of the General Assembly know the concerns of the Association throughout the year and can be proactive for the Association. I would like to add that the success of this communication effort depends on active participation by the entire Association that is driven by a clear plan from the Legislative Committee.

Thank you again for the opportunity to represent the Illinois Forestry Association, and I wish you much success in the future.

Next generation of forest landowners (information about resources for estate planning)

There is a crisis brewing in America's vast forest lands, but it has little to do with the health of the woods: the acreage is essentially the same as it was a century ago, and there is over 30 percent more wood volume per acre than in 1952. At stake are large tracts of private forest that are at risk of falling into mismanagement, subdivision or being sold for development.
